**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") is dated this 20th day of March, 2017, from AMRESKO Commercial Finance, LLC, a Delaware limited liability company, successor by merger to AMRESKO Commercial Finance, Inc., a Nevada corporation, and Wells Fargo Bank, N.A., formerly known as Norwest Bank Minnesota, N.A., as custodian or trustee, acting by and through AMRESKO Commercial Finance, LLC as its Servicing Agent (collectively, the "Secured Party"), whose current address is 202 N. 9th Street, Suite 300, Boise, Idaho 83702, formerly of 412 E. ParkCenter Boulevard, Suite 300, Boise, Idaho 83706, in favor of Concept Acquisitions, LLC, a California limited liability company (the "Grantor"). All capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Security Agreement (defined below).

WITNESSETH:

WHEREAS, pursuant to the Pledge and Security Agreement (the "Security Agreement") dated as of April 21, 2000, the Grantor granted to Secured Party a security interest in the following trademarks (the "Trademarks"):

WHEREAS, the Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the "USPTO") on May 18, 2000 at Reel 2085, Frame 0004; and

WHEREAS, the Secured Party now wishes to release its liens on, and security interests in, the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Secured Party hereby states as follows:

1. Release of Security Interest. The Secured Party hereby terminates, releases and discharges all of its security interest in the Trademarks, and assigns and relinquishes any and all right, title and interest that it may have in or to the Trademarks to the Grantor.
2. Recordation. The Grantor or its authorized agent is authorized to record this Agreement with the USPTO.

3. Further Assurances. The Secured Party shall take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by Grantor, and at Grantor's cost and expense, to more fully and effectively effectuate the release of liens and security interests contemplated hereby.
