## INTELLECTUAL PROPERTY PURCHASE AGREEMENT

This INTELLECTUAL PROPERTY PURCHASE AGREEMENT (this "Agreement") is made and entered into as of 5<sup>th</sup> May, 2014 (the "Effective Date"), by and between UNITED PHOSPHORUS LTD. of The Centre, Birchwood Park, Warrington WA3 6YN ("Seller") and VJS INVESTMENTS LIMITED having its Registered Office at 104 Plot No. 358-615, Al Quoz 3, P.O. Box 17870, Dubai UAE ("Purchaser"). Seller and Purchaser are sometimes herein referred to collectively as the "Parties" and individually as a "Party."

WHEREAS, Seller is the owner of the Intellectual Property (as defined below);

WHEREAS, Purchaser desires to purchase and acquire from Seller the Intellectual Property, and Seller desires to sell, transfer and assign to Purchaser all such intellectual property, in each case on the terms and subject to the conditions set forth herein.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements hereinafter contained, the Parties hereby agree as follows:

### 1. DEFINITIONS

- 1.1. For purposes of this Agreement, the following terms shall have the meanings specified or referred to in this Section 1. Unless the context otherwise requires, such terms shall be equally applicable to both the singular and plural forms.
- 1.2. "Intellectual Property" means all intellectual property rights owned or used by Seller in respect of the following: (a) patent listed in Exhibit A hereto (collectively, the "Patent"); (b) all trademarks listed in Exhibit A hereto (collectively, "Marks"), and (c) all Intellectual Property Documents.
- 1.3. "Intellectual Property Documents" means all documents and things, in any written or electronically recorded form, to the extent in the possession, custody, or control of Seller and can be located, reasonably related to the Intellectual Property or reasonably necessary and required to enable Purchaser to prosecute the application for any Intellectual Property. Such documents and things shall include, without limitation, information relating to the conception and/or reduction to practice of any Intellectual Property, laboratory notebooks, patent prosecution (docket) files, inventor assignments, and invention disclosures.
- 1.4. "Liens" means any consensual or non-consensual lien, encumbrance, pledge, mortgage, deed of trust, security interest, lease, charge, option, right of first refusal, easement, servitude, proxy, voting trust or agreement, transfer restriction under any shareholder or similar agreement, or other interest.
- 1.5. "Person" means any individual, corporation, limited liability company, partnership, firm, joint venture, association, joint-stock company, trust, unincorporated organization, association, estate, governmental body or other entity.
- 1.6. "Purchased Assets" means all right, title and interest of Seller in the Intellectual Property

And, Seller, hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Trademarks to Purchaser as assignee of the entire interest.
