**RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This Release of Second Lien Security Interest in Trademark Collateral is made and effective as of March 17, 2017 (“Release of Security Interest”) by Cortland Capital Market Services LLC, as collateral agent (in such capacity, the “Collateral Agent”), solely in its capacity as Collateral Agent for the lenders from time to time party to that certain Second Lien Credit Agreement dated as of September 17, 2015.

**WHEREAS**, each of (i) Communications & Power Industries LLC, (ii) CPI Malibu Division, and (iii) CPI Locus Microwave, Inc. (collectively, the “Pledgors” and each a “Pledgor”), owns the Trademarks and Trademark applications listed opposite its applicable name on Appendix 1 attached hereto (“Trademarks”), which Trademarks are registered or applications for registration have been filed in the United States Patent and Trademark Office (the “Office”); and

**WHEREAS**, pursuant to that certain Second Lien Security Agreement dated as of September 17, 2015 among the Collateral Agent, the Pledgors and certain other parties thereto from time to time (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), and that certain Second Lien Trademark Security Agreement dated as of September 17, 2015 among the Collateral Agent and the Pledgors (as amended, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), the Collateral Agent was granted a security interest in all of each Pledgor’s Pledged Collateral (as described in the Trademark Security Agreement), including the Trademarks, which Trademark Security Agreement was recorded in the Trademark Division of the Office on September 25, 2015 at Trademark Reel 5630 and Frame 0569; and

**WHEREAS**, the Collateral Agent has released its security interest in all of the Pledged Collateral;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby states as follows:


1. Definitions. Capitalized terms used in this Release of Security Interest and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.
2. Release of Security Interest. The Collateral Agent hereby terminates, discharges, cancels and releases all of its security interests in and liens on all of the Pledged Collateral granted under the Security Agreement and the Trademark Security Agreement, and the Collateral Agent hereby acknowledges and agrees that it has no further interests in the Pledged Collateral, and that the Security Agreement and the Trademark Security Agreement are terminated and of no further force and effect.
3. Governing Law. This Release of Security Interest and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release of Security Interest or the facts or circumstances leading to its execution, whether in contract, tort or

otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

4. Further Assurances. The Collateral Agent hereby agrees, at the Pledgors' sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effectuate the release of the Security Interest contemplated hereby.
