NOW, THEREFORE, the Agent, without recourse, representation, or warranty, and at the Assignor's sole cost and expense, hereby terminates, cancels, and releases its Lien on and continuing security interest in the Intellectual Property Collateral, including the Patents and Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by, the Patents and Trademarks, and any right, title, and interest of the Agent in the Intellectual Property Collateral shall hereby terminate, cease, and become void.

The Agent agrees to provide the Assignor with any information and additional authorization and documentation necessary to effect the release of the Agent's security interest in the Intellectual Property Collateral (without recourse, representation, or warranty and at the Assignor's sole cost and expense).
