**RELEASE OF ASSIGNMENT FOR SECURITY IN TRADEMARKS**

THIS RELEASE OF ASSIGNMENT FOR SECURITY IN TRADEMARKS (this "Release"), dated as of May 1, 2017, is made by **CORTLAND CAPITAL MARKET SERVICES LLC**, a Delaware limited liability company, in its capacity as collateral agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacity, "Grantee") and is as follows:

WHEREAS, **AKA DIVERSIFIED HOLDINGS, INC.**, a South Dakota corporation ("First Grantor"), was a party to that certain Assignment for Security in Trademarks dated as of January 15, 2016 in favor of Grantee (the "First Assignment for Security in Trademarks"), which was recorded with the United States Patent and Trademark Office on January 15, 2016, in its records at Reel 5710, Frame 0328;

WHEREAS, **DIAMOND WIRELESS, LLC**, a Utah limited liability company ("Second Grantor"; together with the First Grantor, the "Grantors"), was a party to that certain Assignment for Security in Trademarks dated as of September 30, 2016 in favor of Grantee (the "Second Assignment for Security in Trademarks"; together with the First Assignment for Security in Trademarks, the "Assignments"), which was recorded with the United States Patent and Trademark Office on October 3, 2016, in its records at Reel 5889, Frame 0702; capitalized terms used but not defined herein will have the meaning given to them in the Assignments;

WHEREAS, the Assignments granted to the Grantee for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of the Grantors in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, but excluding any Excluded Property (as defined in the Security Agreement); and

WHEREAS, Grantee desires to release its rights and security interests in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee hereby (i) fully and finally releases and terminates (a) its security interest and other rights in, to and under the Collateral, including the goodwill of the business symbolized by the Trademarks, and (b) any and all other rights it may have under the Assignments, (ii) agrees that it shall, at the expense of the Grantors, execute all other documents and do all other acts necessary to relinquish and effect the release of such rights and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence release and termination of its rights under each of the Loan Documents with respect to the Collateral.
