**MEMORANDUM AND NOTICE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

The terms and conditions of the aforementioned security interests are contained in that certain Loan and Security Agreement, dated as of February __, 2017 (as amended, restated, amended or restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), by and among Debtor, **PACIFIC POWER GROUP, LLC**, a Washington limited liability company and Lender, as security for the Obligations (as defined in the Loan Agreement) as set forth in the Loan Agreement and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Lender may have in any other collateral described in the Loan Agreement or otherwise.




