ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment of Trademark Rights (this "Assignment") is made and entered into and effective as of the 8th day of November 2016 by and between **RPG DIFFUSOR SYSTEMS, INC.**, a Maryland corporation, whose principal place of business is at 651-C Commerce Drive, Upper Marlboro, Maryland 20772 (hereinafter referred to as the "Assignor") and **RPG ACOUSTICAL SYSTEMS LLC**, a New Jersey limited liability company with a place of business at 99 South Street, Passaic, New Jersey 07055 (hereinafter referred to as the "Assignee") (collectively the Assignor and Assignee shall be referred to as the "Parties").

WHEREAS, the Assignor is the record owner of certain registered and unregistered trademarks as listed on Schedules A and B, the domain name [rpginc.com](http://www.rpginc.com), and the content at the website <http://www.rpginc.com>, together with the applications and licenses for, and the goodwill relating to the foregoing (the "Purchased Trademarks"); and

WHEREAS, Schedule A lists the portion of the Purchased Trademarks that are trademarks currently registered with the United States Patent and Trademark Office (the "USPTO") (the "Purchased Registered Trademarks"); and

WHEREAS, Schedule B lists the portion of the Purchased Trademarks that are trademarks not currently registered with the USPTO (the "Purchased Unregistered Trademarks"); and

WHEREAS, the Assignor sold the Purchased Trademarks to Assignee in the Sale and Purchase Agreement executed between the Assignor and the Assignee executed on November 8, 2016 (the "Sale and Purchase Agreement"); and

WHEREAS, the Assignor, in Section 1.5 of the Sale and Purchase Agreement, assigned all its rights in Purchased Trademarks to the Assignee; and

WHEREAS, the Assignor agreed, in Section 1.5 of the Sale and Purchase Agreement, to sign any and all documents as required to effectuate the assignment of the Purchased Trademarks with the USPTO, and this Assignment is being entered into to effectuate such assignment; and

WHEREAS, the Assignor has duly authorized the execution, delivery, and performance of this Assignment;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor agrees, for the benefit of the Assignee, as follows:

SECTION 1. Assignment. The Assignor hereby assigns, transfers, and conveys the Purchased Trademarks to the Assignee, for the Assignee's benefit.

SECTION 2. Purpose. This Assignment has been executed and delivered by the Assignor for the purpose of recording assignments of the Purchased Registered Trademarks with the USPTO. The assignment effectuated hereby has been granted in connection with the Sale and Purchase Agreement and is expressly subject to the terms and conditions thereof. The Sale and Purchase Agreement (and all rights and remedies of the Parties thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 3. Acknowledgement. The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the sale and assignment of the Purchased Trademarks are more fully set forth in the Sale and Purchase Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.


SECTION 4. Counterparts. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
