**DECLARATION FOR CORRECTION OF OWNERSHIP**

I, Robert P. Felber, Jr., declare as follows:

1. I am legal counsel for Axia Technologies, LLC ("Axia"), a Delaware limited liability company located at 820 State Street, 3<sup>rd</sup> Floor, Santa Barbara, California 93101.
2. This declaration is submitted to correct the chain of title in the records of the U.S. Patent and Trademark Office (the "USPTO") with respect to the following United States registrations (collectively, the "Axia Marks"): (a) Registration No. 4778901 for the mark CORRAL; (b) Registration No. 4825978 for the mark PAYMENT FUSION; (c) Registration No. 4843149 for the mark PAYMENT INTEGRATION AS A SERVICE; and (d) Registration No. 4792120 for the mark AXIAMED.
3. On November 16, 2016, we recorded an entity conversion with the USPTO against each of the Axia Marks, which converted the owner Axia Payments, Inc. from a corporation to a limited liability company, effective as of April 22, 2016 (see Reel/Frame 5921/0437).
4. On November 16, 2016, we also recorded a change of name with the USPTO against each of the Axia Marks, which changed the name of the owner from Axia Payments, Inc. to AXP Acquisition, LLC, effective as of June 2, 2016 (see Reel/Frame 5921/0695).
5. Subsequent to recording the entity conversion described in paragraph 3 and the change of name described in paragraph 4, we discovered that Axia Payments, Inc. had entered into an agreement that assigned the Axia Marks to Axia Technologies, LLC, effective as of April 19, 2016. Because the assignment pre-dated the entity conversion described in paragraph 3 and the


name change described in paragraph 4, the recordations identified in paragraph 3 and paragraph 4 were unnecessary filed because the Axia Marks had already been assigned by Axia Payments, Inc. to Axia Technologies, LLC before the conversion and name change occurred.

6. On April 5, 2017, we recorded the assignment from Axia Payments, Inc. to Axia Technologies, LLC with the USPTO (see Reel/Frame 6027/0658).

7. Based on the foregoing, I respectfully request that you correct the chain of title with respect to the Axia Marks to reflect the fact that the current owner of the Axia Marks is Axia Technologies, LLC.

8. I hereby declare that all statements made herein of my own knowledge are true and correct.

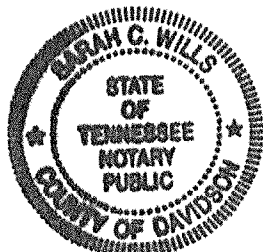
