ASSIGNMENT

legally to issue therefor, and any and all renewals thereof for the Mark, together with the goodwill of the business symbolized thereby, and further including, without limitation, all claims for damages by reason of past infringement and the right to sue for and the right to collect the same for its own use and behoof, and for the use and behoof of its successors, assigns, or legal representatives and the right to defend the Mark and the applications and registrations thereof.

The ASSIGNOR REPRESENTS AND WARRANTS that the ASSIGNEE is a successor to the business of the applicant that is ongoing and existing, or a portion thereof, to which the mark pertains.

The ASSIGNOR REPRESENTS AND WARRANTS that it has the full right, power and authority to make this assignment, and that it has not granted and will not grant any assignment or other encumbrance of the Mark to any third party.
