SERVICE MARK ASSIGNMENT

THIS SERVICE MARK ASSIGNMENT (“Assignment”), dated as of May 10, 2016, is made and entered into by Liberty Title & Escrow Co., a Rhode Island corporation (“Assignor”), in favor of FNTS Holdings LLC, a Delaware limited liability company (the “Assignee”).

WHEREAS, Assignor is the owner of the following service mark:

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all right, title and interest in and to all of the above-identified mark (the “Mark”) and registration (“Registration”), including, without limitation, all common law rights relating to the Mark and all renewals and extensions that may be granted in connection with the Registration, together with the goodwill of Assignor’s business associated with the Mark and Registration;

NOW, THEREFORE, for the payment of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby assigns, sells and sets over to Assignee all right, title and interest in and to the Mark and Registration, together with the goodwill of Assignor’s business symbolized by the Mark and Registration, and all other rights that Assignor has enjoyed thereunder as trademarks, service marks, trade names, domain names and otherwise, including, without limitation, all renewals and extensions that may be granted in connection with the Registration and all rights and remedies based upon past infringement (including the right to sue and collect damages and profits for such infringement).

2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
