TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment (this "Release") is made as of May 26, 2017, by NXT Capital, LLC, as Agent ("Grantee"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreements (as defined below).

W I T N E S S E T H:

WHEREAS, Resource Label Group, LLC, a Tennessee limited liability company ("Grantor") and Grantee are parties to (i) that certain Trademark Security Agreement dated as of April 5, 2011 (the "April Security Agreement"), (ii) that certain Trademark Security Agreement dated as of September 30, 2015 (the "September Security Agreement"), (iii) that certain Trademark Security Agreement dated as of February 9, 2016 (the "February Security Agreement"), (iv) that certain Trademark Security Agreement dated as of November 21, 2016 (the "November Security Agreement"), and (v) that certain Trademark Security Agreement dated as of March 1, 2017 (the "March Security Agreement"); the April Security Agreement, the September Security Agreement, the February Security Agreement, the November Security Agreement, and the March Security Agreement are sometimes individually referred to herein as a "Security Agreement" and collectively as the "Security Agreements", in each case, pursuant to which Grantor granted a security interest to Grantee in certain Trademarks (as defined in the applicable Security Agreement) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 attached hereto;

WHEREAS, the (i) April Security Agreement was recorded by the United States Patent and Trademark Office on April 5, 2011, at Reel 4515, Frame 0552, (ii) September Security Agreement was recorded by the United States Patent and Trademark Office on September 30, 2015, at Reel 5634, Frame 0545, (iii) February Security Agreement was recorded by the United States Patent and Trademark Office on February 9, 2016, at Reel 5727, Frame 0370, (iv) November Security Agreement was recorded by the United States Patent and Trademark Office on November 21, 2016, at Reel 5926, Frame 0927, and (v) March Security Agreement was recorded by the United States Patent and Trademark Office on March 2, 2017, at Reel 6000, Frame 0532;

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"), whether now owned or existing or hereafter created, acquired or arising:

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Grantee hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Trademarks and the Trademark Collateral.

3. Grantee hereby authorizes Grantor or any of its authorized representatives to file this Release with the United States Patent and Trademark Office or any other applicable governmental office. The Grantee hereby further authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
