TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “**Termination and Release**”) is granted as of June 13, 2017 by Orchestra Medical Ventures II, L.P. (“**OMV**”) in favor of Caliber Therapeutics, Inc., a Delaware corporation (“**Grantor**”).

WHEREAS, Grantor entered into a Trademark Security Agreement dated as of January 20, 2016 with OMV and certain other secured parties (the “**Trademark Security Agreement**”), notice of which was recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office on January 20, 2016, at Reel 5712, Frame 0728.

WHEREAS, Grantor granted to OMV and certain other security holders a security interest (the “**Grant**”) in all of Grantor’s right, title and interest in, to and under the trademark and service mark registrations and applications set forth in Schedule I hereto, together with the goodwill symbolized thereby (the “**Collateral**”).

WHEREAS, both OMV and Grantor have agreed to terminate the security interest in the Collateral granted pursuant to the Trademark Security Agreement pursuant to a document suitable for recording in the United States Patent and Trademark Office to evidence the release of the security interests in and liens on the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, OMV hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Collateral, including those trademarks and trademark applications identified in Schedule I hereto; and
2. agrees that it shall, and at Grantor’s or its respective successor’s or assign’s, reasonable request, execute, acknowledge and deliver to Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF DELAWARE.
