## RELEASE OF SECURITY INTERESTS

The Agent hereby authorizes and directs Goodmans LLP, Kirkland & Ellis LLP or their agents to prepare and electronically submit the relevant forms and instruments that are necessary for the purpose of recording the releases and discharges provided for herein in any office where notice of the Agent's security interest in the Trademarks may be registered or recorded.


