I am the attorney of record for Meda Pharma S.a.r.l., in connection with U.S. Registration No. 3,627,478 (ELESTRIN), U.S. Registration No. 3,541,282 (GESTICARE), U.S. Registration No. 2,728,071 (NATELLE), U.S. Registration No. 3,806,629 (URELLE) and U.S. Registration No. 3,844,810 (AVC) (collectively, the “Registrations”).

2. I submit this Declaration pursuant to TMEP § 503.06(b).

3. Meda Pharma S.a.r.l. is the current owner of record for each of the Registrations, pursuant to assignment from Jazz Pharmaceuticals International II Limited (*see*, Trademark Assignment, recorded February 24, 2014, at Reel No. 005222 and Frame Nos. 0404-0408, attached hereto as Exhibit A).

4. Jazz Pharmaceuticals International II Limited was formerly known as Azur Pharma International II Limited (a Bermuda limited liability company). On February 18, 2014, Jazz Pharmaceuticals International II Limited recorded a Change of Name in connection with each of the Registrations (*see*, Reel No. 005218 and Frame Nos. 0381-0383, attached hereto as Exhibit B). The Change of Name documents identify a change of name from “Azur Pharma International Company II Limited” to “Jazz Pharmaceuticals International II Limited”, made on

March 21, 2012 (*see*, cover sheet and recorded document (a “Certificate of Incorporation on Change of Name”, issued by the Bermuda Registrar of Companies on March 27, 2012)).

5. Jazz Pharmaceuticals International II Limited has advised the undersigned declarant that the prior entity name “Azur Pharma International Company II Limited”, as referenced in the Change of Name documents of Exhibit B, contains a typographical error -- namely, the inclusion of the word “Company” -- and has provided the undersigned declarant with the original Certificate of Incorporation (issued by the Bermuda Registrar of Companies on November 23, 2006, and attached hereto as Exhibit C), reflecting the correct spelling of the prior entity name as “Azur Pharma International II Limited”.

6. Jazz Pharmaceuticals International II Limited has also provided the undersigned declarant with a corrected “Certificate of Incorporation on Change of Name”, issued by the Bermuda Registrar of Companies and dated as of March 27, 2012, which properly identifies the change of name from “Azur Pharma International II Limited” to “Jazz Pharmaceuticals International II Limited”, made on March 21, 2012 (attached hereto as Exhibit D).

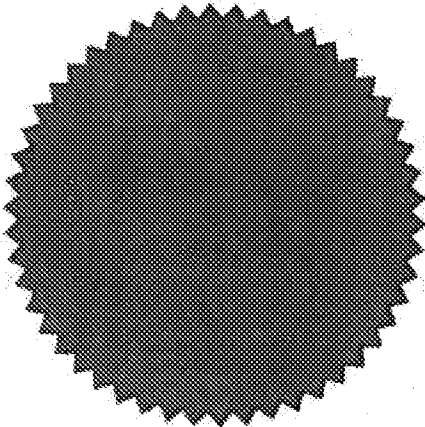

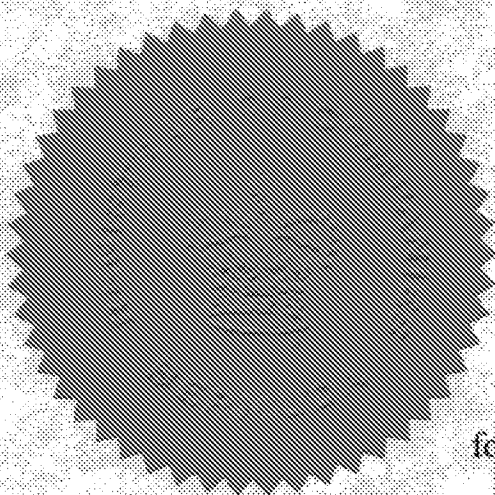

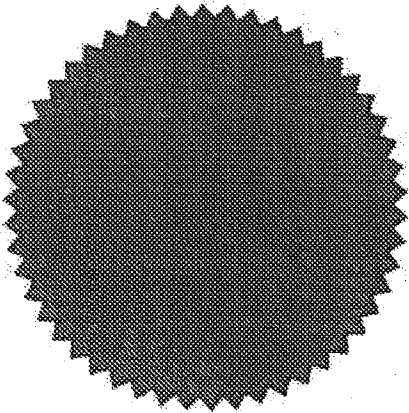
