**RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS**

THIS RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS (this “**Release**”) is made as of June 19, 2017, by BMO HARRIS BANK, N.A. (“**Grantee**”).

WITNESSETH:

WHEREAS, MAJOR LEAGUE SOCCER, L.L.C., a Delaware limited liability company (“**Grantor**”), entered into that certain Confirmatory Grant of Security Interest in Patents, Trademarks and Copyrights dated January 27, 2012 (the “**2012 Security Agreement**”), whereby Grantor granted to Grantee a continuing security interest in all of Grantor’s right, title and interest in, to and under certain patents (the “**2012 Patents**”), trademarks (the “**2012 Trademarks**”) and copyrights (the “**2012 Copyrights**”) as security for certain obligations owing by Grantor to Grantee, including, without limitation, certain of the patents, trademarks and copyrights set forth on Schedule A hereto;

WHEREAS, the 2012 Security Agreement was recorded by the United States Patent and Trademark Office on February 8, 2012 at Reel 4712, Frame 0035;

WHEREAS, Grantor entered into that certain Confirmatory Grant of Security Interest in Patents, Trademarks and Copyrights dated February 25, 2014 (the “**2014 Security Agreement**”, and together with the 2012 Security Agreement, the “**Security Agreements**”), whereby Grantor granted to Grantee a continuing security interest in all of Grantor’s right, title and interest in, to and under certain patents (the “**2014 Patents**”, and together with the 2012 Patents, the “**Patents**”), trademarks (the “**2014 Trademarks**”, and together with the 2012 Trademarks, the “**Trademarks**”) and copyrights (the “**2014 Copyrights**”, and together with the 2012 Copyrights, the “**Copyrights**”) as security for certain obligations owing by Grantor to Grantee, including, without limitation, certain of the patents, trademarks and copyrights set forth on Schedule A hereto;

WHEREAS, the 2014 Security Agreement was recorded by the United States Patent and Trademark Office on February 26, 2014, at Reel 5224, Frame 0009; and

WHEREAS, Grantor has requested that Grantee, and Grantee now desires to, terminate and release its continuing security interest in in the Patents, Trademarks and Copyrights and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby automatically and unconditionally releases and terminates its continuing security interest in all of Grantor’s right, title and interest in and to the Patents, Trademarks and Copyrights then owned or from time to time after the date of the applicable Security Agreement owned or acquired by the Grantor, together with all proceeds and products of the Patents, Trademarks and Copyrights, and all causes of action arising prior to or after the date of the applicable Security Agreement for infringement of any of the Patents, Trademarks or Copyrights, or unfair competition regarding the same (collectively, the “**Collateral**”).

2. Grantee hereby terminates the Security Agreements and fully and finally terminates, discharges, releases, cancels, reassigns, grants and conveys to Grantor, without any representation,

recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Patents, Trademarks and Copyrights.

3. Grantee agrees to execute further documents (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) and to do such other acts as may be necessary or requested by the Grantor to effect the release of the security interest contemplated hereby, in each case at the sole cost of Grantor, who shall promptly reimburse Grantee for all reasonable costs and expenses incurred by Grantee in connection with the foregoing.

4. Grantee hereby authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
