SECOND SUPPLEMENT TO GRANT OF SECURITY INTEREST  
IN UNITED STATES AND CANADIAN TRADEMARKS

This Second Supplement to Grant of Security Interest in United States and Canadian Trademarks (this "Grant") is made as of the 28<sup>th</sup> day of June, 2017, by **RESTORATION HARDWARE, INC.**, a Delaware corporation (the "Grantor") in favor of **BANK OF AMERICA, N.A.**, as Agent (the "Grantee").

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated August 3, 2011 and recorded on August 5, 2011 at Reel 004598, Frame 0401 (as amended of record from time to time, hereinafter, the "2011 Existing Grant"), as supplemented pursuant to that certain First Supplement to Grant of Security Interest in United States and Canadian Trademarks dated November 24, 2014 and recorded with the United States Patent and Trademark Office ("USPTO") on November 25, 2014 at Reel 5407, Frame 0775 with the United States Patent and Trademark Office and with the Canadian Intellectual Property Office ("CIPO") on December 15, 2014 as File No. 1070730 (the "TM Supplement," and together with the 2011 Existing Grant, collectively, the "Original Grant"), pursuant to which the Grantor pledged, assigned and granted a security interest in certain Marks (as defined therein); and


WHEREAS, the Grantor has developed additional Marks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Marks in favor of the Grantee.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Original Grant.
2. Supplement to Schedule A. Schedule A to the Original Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto. For the purposes of clarity, from and after the date hereof, Schedule A shall be deemed to include (i) the Marks referenced on Schedule A as such Schedule A exists immediately prior to the date hereof (including as supplemented pursuant to the TM Supplement), and (ii) the Marks referenced on Schedule A-1 annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Original Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
  - b. This Grant and the Original Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.
