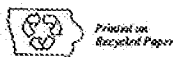

**ARTICLES OF AMENDMENT
OF

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 1002 or 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts the following amendment to the Corporation's Articles of Incorporation.

1. The name of the corporation is Wendl Acquisition Corporation.
2. Article I of the Articles of Incorporation is deleted and the following is inserted in lieu thereof:

ARTICLE I

NAME

The name of this corporation shall be: **Boyle's Famous Corned Beef Co.**
