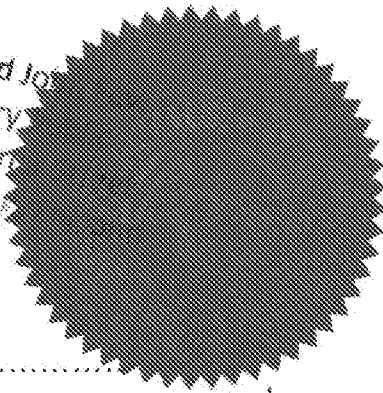

TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (together with Schedule A, this "Agreement") is made and entered into effective as of March 2, 2017 (the "Effective Date") by and between Autonomy Corporation Limited, a United Kingdom private limited company with a business address at Cain Road, Amen Corner, Bracknell, Berkshire RG12 1HN, United Kingdom ("Assignor"), and Autonomy Systems Limited, a United Kingdom private limited company with a business address at Cain Road, Amen Corner, Bracknell, Berkshire RG12 1HN, United Kingdom ("Assignee"). Assignor and Assignee are referred to individually as a "Party" and collectively as the "Parties."

WHEREAS, Assignor and Assignee desire to enter into this Agreement to effect the transfer and assignment to Assignee of all of Assignor's right, title and interest in and to the trademark registrations and pending trademark applications set forth on Schedule A (the "Transferred Trademarks") and associated trademark goodwill;

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants and agreements set forth below, and for other good and valuable consideration of US \$1, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Assignor and Assignee agree as follows.

1. Assignor hereby does sell, assign, transfer, convey, and deliver to Assignee all of Assignor's right, title, and interest in and to the following:
 - (a) the Transferred Trademarks, including without limitation all registrations and applications thereof, all registrations which may be granted in respect of such applications, and all renewals of such registrations;
 - (b) the trademark goodwill of the business symbolized by such Transferred Trademarks; and
 - (c) the entire right, title, and interest in all convention and treaty rights of all kinds, including without limitation all rights of priority in any country of the world, in and to the Transferred Trademarks.
2. Assignor hereby requests that any applicable governmental entity or registrar (including any applicable foreign or international office or registrar), record Assignee as the assignee and owner of the Transferred Trademarks.
3. This Agreement and all the provisions hereof shall be binding upon and shall inure to the benefit of the Parties and their respective successors and permitted assigns. Nothing


herein, express or implied, shall give or be construed to give to any person, other than the Parties and such permitted assigns, any legal or equitable rights hereunder.

4. This Agreement may be executed simultaneously in two or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. This Agreement may be executed by facsimile or .pdf signature, and a facsimile or .pdf signature will constitute an original for all purposes.
5. This Agreement, and any disputes arising out of or relating to this Agreement, will be governed by and construed under the laws of the State of Delaware, without reference to its conflicts of law principles.


