DISCHARGE OF SECURITY INTEREST

WHEREAS, Aftermath Services LLC and Aftermath Holdings LLC (each a "Grantor") and collectively the "Grantors") granted a security interest in the United States trademarks listed in Exhibit A attached hereto (the "Trademarks") and in the other collateral described in the Security Agreement (as defined below) (the "Other Collateral" and, together with the Trademarks, the "Collateral") to Fifth Third Bank ("Lender");

WHEREAS, the Intellectual Property Security Agreement dated as of August 8, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") between the Grantors and the Lender with respect to the Trademarks and the Other Collateral was recorded in the records of the United States Patent and Trademark Office (the "USPTO") on August 15, 2013, and such recordation is located on Reel 5091 at Frame 0814 of the USPTO; and

WHEREAS, the Lender desires to release the Trademarks and the Other Collateral from the Security Agreement.

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Lender of the full amount of the indebtedness described in the Security Agreement, the Lender hereby (a) releases and discharges all the security interests granted by the Security Agreement, being the security interests granted in respect of the Collateral, namely the Trademarks and the Other Collateral, and (b) acknowledges, confirms and agrees that the Security Agreement is discharged, released and terminated and of no further force or effect.

The Lender represents and warrants that: (i) it has the full power and authority to execute this Discharge of Security Interest (Trademarks); and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.

The Lender shall, at Grantors' sole cost and expense, take all further actions, and provide to each Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by such Grantor to more fully and effectively effectuate the purposes of this Discharge of Security Interest (Trademarks).
