

2 Assignment

2.1 Assignment

The Assignor, as legal and beneficial owner, assigns to the Assignee all its right, title and interest in and to the Trade Marks, including:

 (a) all of the Assignor's right, title and interest in respect of the trade mark registrations and applications for registration of the Trade Marks;

- all right, title and interest in respect of any trade mark registrations which may subsequently be obtained in respect of the Trade Marks; and
- (c) the right to sue for, and recover, damages and other relief in relation to any infringement of any of the Trade Marks (including for conversion or detention), including any infringement that may have occurred before the date of this deed.
