TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“Agreement”) is made as of the 2nd day of August, 2017 by and between Michael Quest, an individual (“ASSIGNOR”), and TSI Products, Inc., a Texas corporation (“ASSIGNEE”).

I. BACKGROUND

A. ASSIGNOR is the owner of the trademarks and any and all trade dress associated therewith ("the Marks") as described in Exhibit A attached hereto and incorporated by reference herein, including all common law rights thereto, and together with the goodwill of the business symbolized thereby in connection with the goods and services on which, or in conjunction with which, the Marks are used (“the Products/Services”); and

B. ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its worldwide right, title, and interest in and to the Marks (the “Marks”).

NOW, THEREFORE, ASSIGNOR and ASSIGNEE, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

II. AGREEMENT


1.1 For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR, hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR’S worldwide right, title, and interest in and to the Marks together with (1) the goodwill of the business relating to the Products/Services in respect upon which the Marks are used, or in conjunction with which the Marks are used, and for which they are registered or for which registration application have been filed; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future unfair competition and/or infringement/dilution/misappropriation relating to the Marks; and (3) all rights to sue for past, present and future unfair competition and/or infringement/dilution/misappropriation relating to the Marks.

1.2 ASSIGNOR further conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all rights in the trade dress, labels, and designs associated with the Marks.

1.3 ASSIGNOR further convents that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, titled, and interest in the Marks.


