TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made this 8th day of August, 2017 (the "Release Date") by Fifth Street Finance Corp., a Delaware corporation, as administrative agent for the Lenders (as defined below) (in such capacity, the "Administrative Agent" and, together with the Lenders, the "Secured Parties"), for the benefit of HealthEdge Software, Inc., a Delaware corporation, and Click4Care, Inc., a Delaware corporation (collectively, the "Debtors").

WHEREAS, the Debtors have entered into that certain Credit Agreement, dated as of September 30, 2013, as amended by that certain First Amendment to Credit Agreement, dated as of October 10, 2014 (as amended, the "Credit Agreement"), with the Administrative Agent, and all lenders that are or have been a party thereto from time to time ("Lenders");

WHEREAS, the Debtors have entered into that certain Trademark Collateral Assignment and Security Agreement, dated as of September 30, 2013 with the Secured Parties (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Security Agreement"), pursuant to which the Debtors granted to the Secured Parties security interests and liens in and to certain assets of the Debtors, including, without limitation, the Trademark Collateral (as defined in the Security Agreement), including, without limitation, each registration and application identified in Exhibit A attached hereto and made a part hereof;

WHEREAS, the Secured Parties have filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Trademark Collateral; and

WHEREAS, the Debtors have paid all outstanding amounts currently owing under the Credit Agreement and the other financing documents executed in connection therewith and has requested that the Secured Parties release the security interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the Secured Parties agrees as follows:



1. Release of Security Interest. Effective as of the Release Date, each of the Secured Parties hereby irrevocably and forever terminates, releases and discharges any and all security interests in the Trademark Collateral granted by either or both of the Debtors under the Security Agreement.
2. Recordation of Release. Each of the Secured Parties understands and agrees that this Release may be recorded by or for the Debtors with the USPTO.
3. Further Actions. Each of the Secured Parties further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtors may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to the Debtors and the cost and expense of such documents and actions shall be borne solely by the Debtors.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Credit Agreement and/or the Security Agreement, as applicable.
