Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments, and to do any and all further acts (but without cost to Assignor) reasonably deemed necessary by Assignee to vest in Assignee all right, title, and interest in and to the Marks, and to enable such right, title, and interest to be recorded in the United States Patent and Trademark Office and any other appropriate governmental authority or agency of the United States.

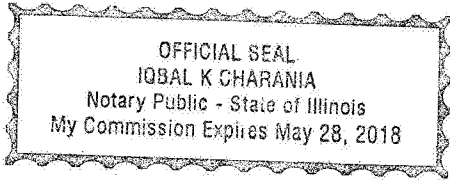
