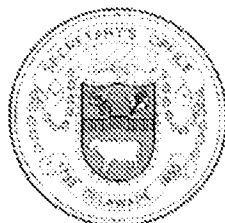





**DOES HEREBY CERTIFY:**

**FIRST:** That at a meeting of the Board of Directors of Amerinet, Inc., resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:
