AFFIDAVIT

I, Kenneth D. Moyes, declare and state as follows:

1. I am the Manager of Worship Facilities Expo LLC, a Delaware limited liability company having its place of business at 111 Speen Street, Suite 200, Framingham, Massachusetts 01701. I have been the Manager of Worship Facilities Expo LLC for over 4 years and I have knowledge of the company's ownership of the trademark shown on Exhibit A (the "Trademark").

2. On January 28, 2014, Production Media, Inc., a North Carolina corporation, executed a Trademark Assignment, attached as Exhibit B, transferring ownership of the Trademark (the "Assignment"). The Assignment listed WFX LLC, a Delaware limited liability company with an address of 111 Speen Street, Suite 200, Framingham, Massachusetts 01701 as the Assignee of the Trademark.

3. At the time of the Assignment, WFX was, and still remains, a dba name for Worship Facilities Expo LLC. WFX LLC and Worship Facilities Expo LLC are the same entity, and Worship Facilities Expo LLC is the correct formal name of the organization.


4. The Assignment inadvertently listed WFX LLC as the name of the Assignee instead of the formal name of the organization, Worship Facilities Expo LLC.


