RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, NextGen Gaming Pty Ltd ACN 090 108 688, an Australian corporation registered in New South Wales under the Corporations Act of 2001, (hereinafter referred to as "Trademark Owner") granted a security interest ("Security Interest") to Equity Financial Trust Company, a trustee acting as a collateral agent on behalf of holders of certain senior secured debentures, in certain trademarks and corresponding trademark registrations and the business and goodwill of the business associated therewith as set forth on Schedule A, attached hereto and made a part hereof (the "Trademarks") pursuant to that certain Trademark Security Agreement dated July 31, 2015 (the "Trademark Security Agreement");

WHEREAS, TMX Equity Transfer and Trust Company succeeded Equity Financial Trust Company as the collateral agent and subsequently changed its name to TSX Trust Company (hereinafter referred to as the "Secured Party");

WHEREAS, the Security Interest in the Trademarks was granted on July 31, 2015;


WHEREAS, the Secured Party is desirous of releasing the Security Interest in the Trademarks to the Trademark Owner;


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Trademark Security Agreement is hereby automatically terminated and shall be of no further force and effect and the Secured Party hereby releases unto Trademark Owner, and to the successors and assigns of Trademark Owner, the Security Interest in the Trademarks, including without limitation any security interests which the Secured Party may have obtained to the Trademarks; and

The Secured Party agrees to execute and deliver to the Trademark Owner all other instruments and other documents as may be necessary or proper to release the Security Interest in the Trademarks, and the Secured Party agrees that the Trademark Owner or its authorized representatives may record this Release with the U.S. Patent and Trademark Office and/or any other applicable governmental office or agency. This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
