RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 18, 2017 (the “Effective Date”), is made by CITICORP NORTH AMERICA, INC., in its capacity as collateral agent for the Secured Parties (as defined in the below-defined Collateral Agreement) (in such capacity, together with its successors and assigns in such capacity, the “Agent”), in favor of CLUBCORP USA, INC., a Delaware corporation (the “Borrower”) and those entities listed as “Record Owner” on Schedule A hereto (together with the Borrower, collectively, the “Grantors”).

WHEREAS, pursuant to that certain Guaranty and Security Agreement, dated as of November 30, 2010, by and among the Agent, the Grantors and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), the Grantors granted to the Agent, in its capacity as collateral agent for the Secured Parties, a security interest in and to the Collateral (as defined in the Collateral Agreement);

WHEREAS, pursuant to the Collateral Agreement, the Grantors executed and delivered (i) that certain Trademark Security Agreement, dated as of November 30, 2010 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), in favor of the Agent and (ii) that certain Second Trademark Security Agreement, dated as of April 19, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Second Trademark Security Agreement”, and, together with the Trademark Security Agreement, the “IP Security Agreements”), and such IP Security Agreements have been recorded with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 13, 2010 at Reel/Frame 004432/0353;

WHEREAS, the Second Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 3, 2011 at Reel/Frame 004533/0346; and

WHEREAS, the Agent has agreed to release, discharge, terminate and cancel its security interest in the Trademark Collateral (as defined in each of the IP Security Agreements) , together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in or otherwise referenced in the Collateral Agreement or the IP Security Agreements, as applicable.

2. Release of Collateral. The Agent, without representation or warranty of any kind, hereby (a) terminates the IP Security Agreements and (b) releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral (as defined in each of the IP Security Agreements), including, without limitation, the trademarks and trademark applications, together with the goodwill of the business symbolized thereby, set forth on Schedule A attached hereto (collectively, the “Released Trademark Collateral”), arising under the Collateral Agreement and the IP Security Agreements, and hereby reassigns, grants and conveys to the Grantors any and all of the Agent’s right, title and interest, if any, in, to and under the Released Trademark Collateral.


3. Recordation. The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

4. Governing Law. **THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.**


