This Assignment is made pursuant to that certain Asset Purchase Agreement made and entered into as of October 31, 2016 by and between Buyer, Harrell's Equipment & Supply Co., Inc., an Indiana corporation, doing business as Harrell's Car Wash Systems ("Harrell's) Product Transportation Services, Inc., an Indiana corporation ("Product"), Equipment Leasing Services, Inc., an Indiana corporation ("Leasing") Harrell Realty, LLC, and Indiana limited liability company ("Realty" and collectively with Harrell's Product and Equipment, the "Sellers") and the Owner (the "Agreement"). To the extent any conflict between the terms of this Assignment and the Agreement, the terms of the Agreement shall prevail and control.
