TRADEMARK ASSIGNMENT

WHEREAS, Assignor’s predecessors-in-interest filed intent-to-use trademark applications on November 5, 2015 and February 4, 2016, respectively, thereafter adopted use of the trademarks (the “Marks”) anywhere at least as early as May 5, 2016 and in Interstate Commerce at least as early as May 7, 2016 and September 6, 2016, respectively, used the Marks and Assignor has used and is the owner of the Marks, identified as follows:

AND, WHEREAS, it is desired that the assignment of the Marks identified herein be made of record in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and transfer to its successor Assignee its entire right, title and interest in and to the Marks and the applications identified above, together with development and marketing to which the Marks pertain, all of the goodwill symbolized by the Marks, and any and all chose in action and rights of recovery based on past infringement of said Marks and/or applications, the same to be held and enjoyed by Assignee, its successors and assigns.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record Assignee as the assignee of all Assignor's right, title and interest in and to the Marks in accordance with the terms of this instrument.

Assignor agrees to assist Assignee in every legal way to evidence, record and perfect the assignment of the Marks described in the Recitals above and to apply for and obtain recordation of, and from time to time to enforce, maintain and defend the Marks.

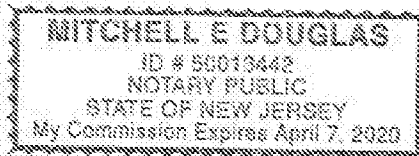
