TRADEMARK ASSIGNMENT

This ASSIGNMENT between Dragos Ideliu, an individual residing at 92 Aldine Ave., Bridgeport, Connecticut 06604 ("Assignor") and STAR CO Scientific Technologies Advanced Research Co., LLC, dba STAR CO, a Texas limited liability company having its principal place of business at P.O. Box 3107 Longview, Texas 75606 ("Assignee"), is executed and delivered as of the Execution Date set forth below.

Whereas, Assignor and Assignee are parties to a Trademark Agreement, dated on or about August 14, 2017 (the "Agreement"), by and between Assignor and Assignee, pursuant to which Assignor agreed to assign all of its rights in the mark STARKACE, together with the goodwill of the business symbolized by the STARKACE mark (the "Goodwill"), to Assignee;

Now, therefore, for good and valuable consideration acknowledged by Assignor to have been received in full from Assignee and pursuant to the terms of the Agreement, Assignor hereby agrees as follows:

1. Assignor hereby conveys, assigns, sells, and transfers to Assignee its entire right, title and interest in and to the STARKACE mark, including all common law trademark rights, together with the Goodwill, to be held and enjoyed by Assignee or its Affiliates for the full extent of the life of the STARKACE mark, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made. This Assignment includes the specific applications, domains and social media accounts identified in Exhibit A hereto. Without limiting the generality of the foregoing, this Assignment shall include all common law trademark rights in the STARKACE mark, and any and all rights to sue for claims and remedies against past, present and future infringements of any or all of the foregoing, and rights for priority and protection of interests therein under the laws of any jurisdiction.

2. Assignor represents, warrants and covenants that Assignor is the owner of the entire right, title and interest in and to the STARKACE mark, and that Assignor has full power to make this Assignment.


3. Notwithstanding any provisions of this Assignment to the contrary, nothing contained in this Assignment shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions, including warranties, covenants, agreements, conditions, representations, or in general any of the rights and remedies, and any of the obligations of Assignor or Assignee set forth in the Agreement nor shall this Assignment expand or enlarge any remedies under the Agreement. This Assignment is intended only to effect the transfer of certain property pursuant to the Agreement and shall be governed entirely in accordance with the terms and conditions of the Agreement.

4. This Assignment shall be construed, performed and enforced in accordance with, and governed by the laws of the State of Texas, without giving effect to the principles of conflicts of laws thereof.

5. This Assignment shall be binding on, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.
