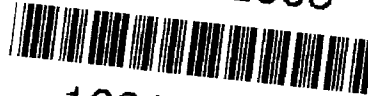



**1 ASSIGNMENT**

Gameworks hereby assigns to LBG all right, title and interest (including the present and future copyright and all other intellectual property rights) in and to the Trade Mark throughout the world in perpetuity.

**2 WARRANTIES**

Gameworks warrants to LBG that the rights assigned under clause 1 are vested in Gameworks free from encumbrances and Gameworks is free to assign those rights to LBG.

**3 NO PAYMENT**

Gameworks agrees that there is to be no payment to Gameworks for the assignment of rights set out in clause 1.

**4 RIGHT TO TAKE ACTION**

Gameworks's assignment of all right title and interest in the Trade Mark under clause 1 includes the right to take action and recover damages, an account of profits or both against third parties for infringement or misuse of those rights which may have occurred prior to, or which may occur on and from the date of this deed.

**5 RECORD OF ASSIGNMENT**

LBG agrees to apply to record the assignment of the Trade Mark with the US Patent and Trade Marks Office (*USPTO*) and to bear all costs, fees and stamp duty in connection with this assignment and its recordation. Gameworks agrees that LBG may provide a copy of this deed to the USPTO.

**6 ENTIRE AGREEMENT**

This agreement contains the entire agreement between the parties with respect to its subject matter and may not be modified except by an agreement in writing signed by the duly authorised representatives of the parties.

**7 FURTHER DOCUMENTS**

Each party must do everything, and sign and deliver all documents, reasonably required by the other to give full effect to this agreement.

**8 GOVERNING LAW**

The law of New South Wales governs this agreement and each party submits to the non-exclusive jurisdiction of the New South Wales courts.

**Trade Mark** means the trade mark that is the subject of US Trade Mark Serial No. 78494425 for the words "Heart of Africa" in class 9.




