## TERMINATION OF TRADEMARK SECURITY INTEREST

This is a Termination of Trademark Security Interest, dated as of October 4th, 2017 (this "Termination"), executed by or on behalf of KeyBank National Association, (formerly Key Bank of Vermont, Bank of Vermont and/or Burlington Savings Bank), a Vermont corporation (the "Secured Party"), releasing all security interests of the Secured Party in the Trademark (defined below) owned by Bruegger's Enterprises, Inc., a Delaware corporation (the "Debtor").

### RECITALS

A. On or about December 23, 1994, the Debtor and the Secured Party entered into a credit agreement (the "Credit Agreement"). In connection with the entry into the Credit Agreement, Debtor and Secured Party executed a Trademark Collateral Assignment and Security Agreement (the "Security Agreement"), pursuant to which the Debtor granted to the Secured Party a security interest in certain assets of the Debtor, including, without limitation, the trademark specifically described on Schedule 1 attached hereto (the "Trademark").

B. In connection with the payoff in full of the Debtor's obligations under the Credit Agreement on or about June 7, 1996, the Security Agreement was terminated, and the Secured Party agreed to terminate and release all of its security interest in the Trademark (the "Release").

C. Due to a clerical error in connection with the Release, the recorded security interest in the Trademark was not released.

D. In order to rectify the clerical error, the Secured Party has agreed to execute this Termination in order to further evidence the Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby agrees as follows:

### AGREEMENT

1. Termination of Security Interest. The Secured Party hereby terminates and releases all of the Secured Party's right, title and interest in, to and under the Trademark.
2. Revocation of Power of Attorney. Any powers of attorney granted by the Debtor to the Secured Party in connection with the grant of the security interest in the Trademark is hereby revoked.
