TRADE MARK DEED OF ASSIGNMENT

THIS DEED is effective on 12th day of October 2017

BETWEEN

- 1) **WIN (GIBRALTAR) LIMITED**, a company registered in Gibraltar with registration number 107159 whose registered office is at Suite 6, Atlantic Suites, Europort Avenue, Gibraltar (the "Assignor"); and
- 2) **ELECTRAWORKS LIMITED**, a company registered in Gibraltar, (company number 94014) whose registered office is at Suite 6, Atlantic Suites, Europort Avenue, Gibraltar (the "Assignee").

WHEREAS

- (A) The Assignor is the proprietor of the trade marks in the United States which is the subject of the applications and/or registrations listed in the attached schedule (the "Trade Marks").
- (B) The Assignor wishes to assign and the Assignee wishes to take the assignment of the Trade Marks subject to the terms of this Agreement.

BY THIS DEED IT IS AGREED THAT

1. In consideration of £1 (one pound sterling) paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges), the Assignor hereby assigns to the Assignee all its right, title and interest in and to the Trade Marks, as well as all goodwill related and attached to the Trade Marks.
2. The Assignor assigns all rights of action arising or accrued relating to the Trade Marks including, without limitation, the right to take proceedings for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks and to seek and recover damages and all other remedies for all past infringement.
3. The Assignee shall bear the cost of recording this assignment at the appropriate registries and shall, from the effective date of this Deed, hereafter bear the cost of further prosecution and registration of the application for the Trade Marks.
4. The Trade Marks are assigned "as is". The Assignor gives no warranties with regard to the Trade Marks, whether in respect of their validity, non-infringement of third party rights or otherwise.
5. This Deed shall be governed by the law of England and subject to the non-exclusive jurisdiction of the High Court of England and Wales.


