AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to the provisions of A.R.S. §§ 10-1001 *et seq.*, the undersigned corporation adopts the following amendment to its Articles of Incorporation:

1. The name of the corporation is MicroBlend Technologies, Inc. (the "Company".)
2. Pursuant to A.R.S. §§ 10-1003, the Board of Directors on August 20, 2009 adopted and recommended to the Shareholders, and the Shareholders of the Company on October 15, 2009 adopted, the following amendments to the Company's Articles of Incorporation:
 - a. Article 1 is hereby deleted and the following new Article 1 is inserted in lieu thereof:
 1. The name of the corporation is MicroBlend, Inc.
 - b. The first sentence of Section 4(d) of Exhibit A to the Certificate of Designation dated December 5, 2008 and filed December 8, 2008, which Certificate designates the rights, preferences and privileges of Series A5 Convertible Preferred Stock of the Corporation, is hereby deleted and the following new first sentence of Section 4(d) is inserted in lieu thereof:

The Conversion Price shall initially be One Dollar and Seventy-Five Cents (\$1.75).
3. Except as expressly amended herein, all other provisions of the Articles of Incorporation of this Company shall remain unchanged and in full force and effect as originally filed with the Corporation Commission, and as heretofore amended by articles of amendment previously filed with the Corporation Commission.
4. The number of shares of the no par value common stock ("Common Stock") of the Company issued and outstanding at the time of such adoption and entitled to vote thereon was 12,108,347.
5. The number of shares of voting preferred stock ("Preferred Stock") of the Company issued and outstanding at the time of such adoption and entitled to vote thereon was 15,754,395.
6. 10,115,884 shares of Common Stock and 15,109,539 shares of Preferred Stock voted for the amendment to Article 1. No shares of Common Stock or Preferred Stock voted against the amendment to Article 1. There are no other shares of any class of stock issued besides Common Stock and Preferred Stock that were outstanding, and entitled to





7. 10,022,884 shares of Common Stock and 15,077,903 shares of Preferred Stock voted for the amendment to Section 4(d) of Exhibit A to the Certificate of Designation dated December 5, 2008 and filed December 8, 2008. 93,000 shares of Common Stock voted against the amendment and 31,636 shares of Preferred Stock voted against the Amendment. There are no other shares of any class of stock issued besides Common Stock and Preferred Stock that were outstanding, and entitled to vote.
8. The number of shares of Common Stock and Preferred Stock cast for the amendments was sufficient for approval.
