

This agreement shall be binding upon, and inure to the benefit of the parties, their successors and assigns.

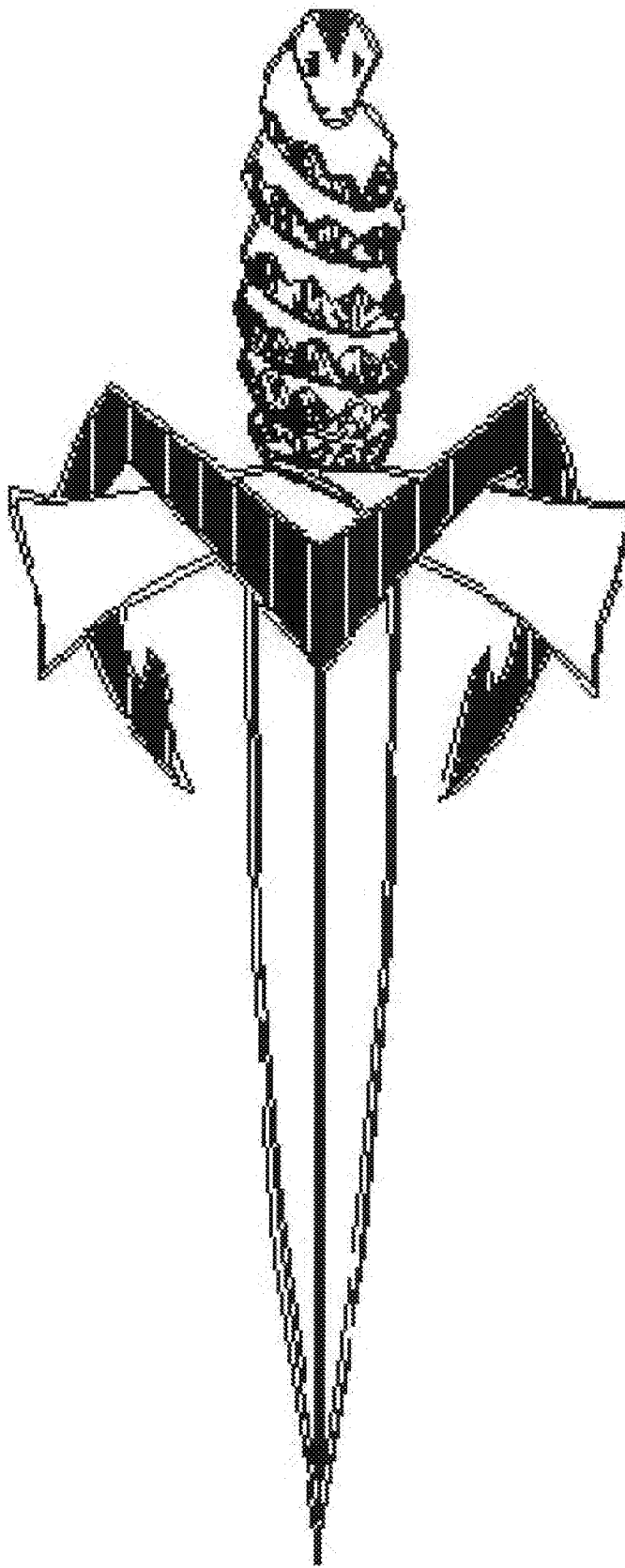
