**FIRST LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This First Lien Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of November 1, 2017, by DEUTSCHE BANK TRUST COMPANY AMERICAS, a New York trust company, in its capacity as administrative agent (the “Administrative Agent”) in favor of JPAY, INC., a Florida corporation with an address at 12864 Biscayne Blvd., Suite 243, Miami, Florida 33181 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 31, 2015 (the “Trademark Security Agreement”) with the Administrative Agent, notice of which was recorded on July 31, 2015 at the United States Patent and Trademark Office at Reel 5589, Frame 0885.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to its Trademark Collateral, including the trademarks listed in Schedule I, and the goodwill connected with the use thereof and symbolized thereby.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its Security Interest in the Trademark Collateral of the Grantor, and the goodwill connected with the use thereof and symbolized thereby, and assigns, transfers and conveys to Grantor any right, title or interest the Administrative Agent may have in the foregoing.
