- FIRST: The name of the corporation is Xyron, Inc.
- SECOND: Attached hereto as Exhibit A is the text of the amendment to the Articles of Incorporation of the corporation adopted.
- THIRD: The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- FOURTH: The amendment was adopted May 5, 2014.
- FIFTH: The amendment was approved by the shareholders. There is one voting group eligible to vote on the amendment. The designation of the voting groups entitled to vote separately on the amendment, the number of votes in each, the number of votes represented at the meeting at which the amendment was adopted and the votes cast for and against the amendment were as follows:

The voting group consisting of 1,492,603 outstanding shares of Series A Common Stock is entitled to 1,492,603 votes. There were 1,492,603 votes received via an action by written consent. The voting group cast 1,492,603 votes for and 0 votes against approval of the amendment. The number of votes cast for approval of the amendment was sufficient for approval by the voting group.

The Articles of Incorporation are amended to read as follows:

"The name of the corporation is Esselte Corporation."
