**RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made effective as of November 9, 2017, by Thirsty Ventures, Inc., a Massachusetts corporation (the "Secured Party") in favor of Lyons Magnus, Inc., a California corporation (the "Company").

WHEREAS, the Company issued that certain Secured Promissory Note dated as of October 15, 2014 (the "Note") in favor the Secured Party;

WHEREAS, the Company has granted security interests to the Secured Party under the Intellectual Property Security Agreement dated as of October 15, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Company granted the Secured Party, among other collateral as set forth therein, a security interest in and lien on the trademarks identified on Exhibit A hereto (the "Trademark Collateral");

WHEREAS, the granting of the security interest in the Trademark Collateral was recorded with the United States Patent and Trademark Office against the Trademark Collateral on October 16, 2014 at Reel number 5382 and Frame number 0182; and

WHEREAS, the Company has satisfied all of the obligations under the Note and the Security Agreement and has requested that the Secured Party terminate and release its security interests in and liens on the Trademark Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Note or the Security Agreement, as the case may be.

2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the Trademark Collateral, including, without limitation, the trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Company, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such trademarks, effective as of the date set forth above.


