RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This Release of Security Interest in Trademark Rights, dated as of November 16, 2017 (the "Trademark Security Release"), is made by Morgan Stanley Senior Funding, Inc., as the Collateral Agent for the several banks and other financial institutions (the "Lenders") party to the First Lien Credit Agreement (as defined below) (in such capacity, the "Agent"), in favor of Radial, Inc. (formerly known as eBay Enterprise, Inc.), a Pennsylvania corporation and Radial South, L.P. (formerly known as Innotrac, L.P.), a Georgia limited partnership (each a "Grantor" and collectively the "Grantors"). Capitalized terms used and not defined herein have the meanings given to such terms in the First Lien Credit Agreement and the Security Agreement (each, as defined below).

WHEREAS, Radial Holdings, L.P. (formerly known as Blue Eagle Holdings III, L.P.), a Delaware limited partnership (the "Borrower") and Radial II, L.P. (formerly known as Blue Eagle Holdings II, L.P.), a Delaware limited partnership ("Holdings"), entered into that certain First Lien Credit Agreement, dated as of November 2, 2015, with the Lenders and Agent, pursuant to which the Lenders severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein (the "First Lien Credit Agreement");

WHEREAS, in connection with the First Lien Credit Agreement, the Borrower, Holdings and certain of the Borrower's domestic subsidiaries, including the Grantors (together, the "Guarantors"), executed and delivered a First Lien Security Agreement, dated as of November 2, 2015 in favor of the Agent (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in certain Intellectual Property, including the Trademarks (collectively, the "Trademark Collateral");

WHEREAS, in connection with the Security Agreement, the Grantors executed and delivered that certain Grant of Security Interest in Intellectual Property Rights agreement dated as of November 2, 2015 made by and between the Grantors and the Agent (the "Intellectual Property Security Agreement") for recording with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on November 19, 2015 on Reel/Frame 5673/0055;

WHEREAS, the Obligations (as defined in the First Lien Credit Agreement) secured by the Trademark Collateral have been repaid or otherwise satisfied; and

WHEREAS, the Agent therefore desires to release, terminate and discharge its Lien and security interest in and to the Trademark Collateral and grant all of its right, title and interest in the Trademark Collateral to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent and the Grantors hereby agree as follows:

1. The Agent hereby releases, terminates and discharges to the Grantors (a) the Agent's continuing security interest in, right of setoff against and Lien on, and (b) any of the Agent's other rights, title or interest of any kind or nature in, to or under, the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule 1 hereto.

2. The Agent hereby authorizes and acknowledges the termination of the Intellectual Property Security Agreement. At Grantor's expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby and terminate the Intellectual Property Security Agreement.






