TRADEMARK COLLATERAL AGREEMENT

This Trademark Collateral Agreement (this "Trademark Collateral Agreement") is made as of December 1, 2017, by Munch's Supply LLC, a Delaware limited liability company ("Debtor") with its principal place of business and mailing address at 1901 Ferro Drive, New Lenox, Illinois 60451, in favor of JPMorgan Chase Bank, N.A., with its mailing address at 10 S. Dearborn Street, Chicago, Illinois 60603, and its successor and assigns ("Secured Party").

WHEREAS, the Debtor has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Debtor has entered into a Security Agreement, dated December 1, 2017 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of Secured Party; and

WHEREAS, pursuant to the Security Agreement, the Debtor has granted to the Secured Party, a continuing security interest in all right, title and interest of the Debtor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

NOW, THEREFORE, as collateral security for the payment, performance and observance of all of the Secured Obligations, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor does hereby grant to the Secured Party, a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

The Debtor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

This Trademark Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart by facsimile or electronic mail shall be equally effective as delivery of an original executed counterpart.

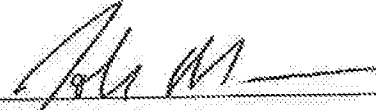
