**TRADEMARK SECURITY AGREEMENT**

**Trademark Security Agreement**, dated as of December 8, 2017, by Quality Park, LLC, a Delaware limited liability company (the “**Grantor**”), in favor of BANK OF AMERICA, N.A., in its capacity as administrative agent and collateral agent pursuant to the Credit Agreement (in such capacities, the “**Administrative Agent**”).

WITNESSETH:

WHEREAS, the Grantor is party to a Security Agreement dated as of September 30, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) in favor of the Administrative Agent pursuant to which the Grantor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Grantor hereby agrees with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. The Grantor hereby pledges and grants to the Administrative Agent for the benefit of the Priority Payment Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the Trademark Collateral. The Grantor hereby pledges and grants to the Administrative Agent for the benefit of the Non-Priority Payment Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the Trademark Collateral. “**Trademark Collateral**” shall mean the following Collateral (excluding any Excluded Property) of the Grantor:

- (a) Trademarks of the Grantor, including those listed on Schedule I attached hereto.

SECTION 3. The Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Security Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Conflicts; Customary Intercreditor Agreement. Notwithstanding anything herein to the contrary, the Liens and security interest granted to the Administrative Agent pursuant to this Trademark Security Agreement and the exercise of any right or remedy by the Administrative Agent hereunder are subject to the provisions of the Pari Intercreditor Agreement (and any other intercreditor agreement entered into by the Administrative Agent pursuant to the Credit Agreement). In the event of any conflict between the terms of the Pari Intercreditor Agreement (or such other intercreditor agreement, as applicable) and this Trademark Security Agreement, the terms of the Pari Intercreditor Agreement (or such other intercreditor agreement, as applicable) shall govern and control. The provisions of the Pari Intercreditor Agreement shall at all times apply to the Obligations and Secured Parties even if the Pari Intercreditor Agreement is not in effect at such time.

SECTION 5. Termination. Upon the termination of the Security Agreement in accordance with Section 6.11 thereof, the Administrative Agent shall, at the expense of the Grantor, execute, acknowledge, and deliver to the Grantor an instrument in writing in recordable form releasing the lien on and security interest in the Trademarks under this Trademark Security Agreement.

SECTION 6. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Trademark Security Agreement by signing and delivering one or more counterparts.


