## DEED OF RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This DEED OF RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (the "Release"), dated as of December 12, 2017 (the "Release Date"), is made by and between RealNetworks, Inc., a Washington corporation located at 1501 First Avenue South, Suite 600, Seattle, Washington 98134, United States of America, as the secured party ("Assignor") and Gaming Realms Plc, a UK company located at One Valentine Place, London SE1 8QH, United Kingdom, as pledgor ("Assignee") pursuant to the Grant of Security Interests (the "Security Interests").

### WITNESSETH

WHEREAS, Assignor and Assignee are parties to the Trademark Security Agreement, dated August 10, 2015, the Patent Security Agreement, dated 10 August, 2015, and the Copyright Security Agreement, dated as 10 August, 2015 (collectively the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, Assignee executed and delivered to Assignor the Grant of Security Interests, dated August 10, 2015;

WHEREAS, pursuant to the Grant of Security Interests, Assignee pledged and granted to Assignor, for its benefit, a security interest in certain intellectual property owned by Assignee, which intellectual property is set forth and described more fully on Schedules A, B, and C annexed hereto, including all related goodwill (collectively, the "IP Collateral");

WHEREAS, the Grant of Security Interests in trademarks was recorded with the United States Patent and Trademark Office on August 10, 2015 at Reel/Frame 5596/0769, and the Grant of Security Interests in patents was recorded with the United States Patent and Trademark Office on August 10, 2015 at Reel/Frame 036315/0968, and the Grant of Security Interests in copyrights with recorded with the US Copyright Office under number V9928D131;

WHEREAS, Gaming Realms has satisfied the terms of the Security Agreements, and Assignor and Assignee desire that Assignor terminate and release its security interest in and to the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates, releases and discharges fully its security interest in, to and under the IP Collateral, and reassigns and transfers any right, title and interest that Assignor may have in the IP Collateral to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (a) record this Release with the United States Patent and Trademark Office; (b) if necessary, file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of Assignor in the IP Collateral; and/or (c) otherwise record or file this Release in other applicable governmental offices or agencies.

Assignor acknowledges and agrees that Assignee and its respective successors and assigns may rely upon this Release. Assignor represents and warrants that it has not transferred or assigned all or any part of its security interest in, to and under the IP Collateral, and that it has all necessary authority to execute this Release and grant all other rights set forth herein.


