RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 27, 2017 (the “Effective Date”), is made by JPMORGAN CHASE BANK, N.A., in its capacity as Collateral Agent (the “Agent”), in favor of CHURCHILL DOWNS INCORPORATED, CHURCHILL DOWNS TECHNOLOGY INITIATIVES COMPANY, CHURCHILL DOWNS LOUISIANA HORSE RACING COMPANY, L.L.C., ARLINGTON PARK RACECOURSE, LLC, YOUTUBE.COM, SW GAMING LLC and UNITED TOTE COMPANY (collectively, the “Grantors”).

WHEREAS, pursuant to the Second Amended and Restated Security Agreement, dated as of December 22, 2009, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Second Amended and Restated Security Agreement”), the Grantors granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Third Amended and Restated Security Agreement, dated as of May 17, 2013, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Third Amended and Restated Security Agreement” and together with the Second Amended and Restated Security Agreement, the “Security Agreements”), the Grantors granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreements, the Grantors executed and delivered for recordal with the United States Trademark Office the supplemental intellectual property security agreements listed on Annex A hereto (together, the “Trademark Security Agreements”);

WHEREAS, the Trademark Security Agreements were recorded with the United States Trademark Office at the location listed on Annex A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreements or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the Trademark registrations and applications set forth Schedule 1 attached hereto, arising under the Security Agreements and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably

requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the Commonwealth of Kentucky, without regard to conflicts of law or choice of law principles.


