**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of December 22, 2017 by CITICORP NORTH AMERICA, INC., as collateral agent (together with its successors and assigns in such capacity, the "Agent") for the Secured Parties (as defined in the Collateral Agreement (as defined below)) in favor of RIO PROPERTIES, LLC, a Nevada limited liability company ("Rio Properties"), PARIS LAS VEGAS OPERATING COMPANY, LLC, a Nevada limited liability company ("Paris Las Vegas"), HARRAH'S LAS VEGAS, LLC, a Nevada limited liability company ("Harrah's Las Vegas") HARRAH'S ATLANTIC CITY PROPCO, LLC, a Delaware limited liability company ("Harrah's Atlantic City"), and FLAMINGO LAS VEGAS OPERATING COMPANY, LLC, a Nevada limited liability company ("Flamingo Las Vegas") (each a "Pledgor" and collectively, the "Pledgors").

**WITNESSETH**

WHEREAS, Caesars Entertainment Resort Properties, LLC, Caesars Entertainment Resort Properties Finance, Inc., Harrah's Las Vegas, Harrah's Atlantic City Holding, Inc., Rio Properties, Flamingo Las Vegas Holding, LLC, Harrah's Laughlin, LLC, Paris Las Vegas Holding, LLC (collectively, the "Borrowers"), each subsidiary of the Borrowers identified in the Collateral Agreement, and the Agent entered into that certain Collateral Agreement (First Lien) dated as of October 11, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, pursuant to the Collateral Agreement, (i) Rio Properties executed and delivered to the Agent that certain Trademark Security Agreement (First Lien) dated as of October 11, 2013 (the "Rio Properties Trademark Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on October 23, 2013 at Reel/Frame No. 5136/0247, (ii) Paris Las Vegas executed and delivered to the Agent that certain Trademark Security Agreement (First Lien) dated as of October 11, 2013 (the "Paris Las Vegas Trademark Security Agreement") and recorded with the USPTO on October 23, 2013 at Reel/Frame No. 5136/0259, (iii) Harrah's Las Vegas executed and delivered to the Agent that certain Trademark Security Agreement (First Lien) dated as of October 11, 2013 (the "Harrah's Las Vegas Trademark Security Agreement") and recorded with the USPTO on October 23, 2013 at Reel/Frame No. 5136/0266, (iv) Harrah's Atlantic City executed and delivered to the Agent that certain Trademark Security Agreement (First Lien) dated as of October 11, 2013 (the "Harrah's Atlantic City Trademark Security Agreement") and recorded with the USPTO on October 23, 2013 at Reel/Frame No. 5136/0273 with a corrective filing at Reel/Frame No. 5141/0673, (v) Flamingo Las Vegas executed and delivered to the Agent that certain Trademark Security Agreement (First Lien) dated as of October 11, 2013 (the "Flamingo Las Vegas Trademark Security Agreement" and collectively with the Rio Properties Trademark Security Agreement, the Paris Las Vegas Trademark Security Agreement, the Harrah's Las Vegas Trademark Security Agreement and the Harrah's Atlantic City Trademark Security Agreement, the "Trademark Security Agreements") and recorded with the USPTO on October 23, 2013 at Reel/Frame No. 5136/0280, pursuant to which the Pledgors granted to the Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of the Pledgors' right, title and interest in or to any and all of the IP Collateral (as defined in the Trademark Security Agreements); and

WHEREAS, the Pledgors have requested that the Agent release its security interest in all right, title and interest in or to any and all of the IP Collateral.



security interest in all right, title and interest in or to any and all of the IP Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the IP Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgors, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the IP Collateral under the Collateral Agreement and the Trademark Security Agreements.
