RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “**Release**”), dated as of January 9, 2018, is made by **VENTURE LENDING & LEASING V, INC.**, as secured party (the “**Secured Party**”), under the Intellectual Property Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Intellectual Property Security Agreement).

WHEREAS, in connection with that certain Loan and Security Agreement, dated as of November 9, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the “**Loan and Security Agreement**”), by and among **MMJK, Inc.** (“**Grantor**”), as borrower, and Secured Party, as lender, Secured Party agreed to make certain advances of money and to extend certain financial accommodations to Grantor;

WHEREAS, pursuant to the terms of that certain Intellectual Property Security Agreement, dated as of November 9, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among Grantor and Secured Party, and recorded with the United States Patent and Trademark Office on November 12, 2009 at Reel 004097, Frame 0644, Grantor conditionally granted to Secured Party security interests in certain trademarks owned by Grantor including those listed on Annex I attached hereto (collectively, the “**US Trademark Collateral**”); and

WHEREAS, all of the outstanding obligations under the Loan and Security Agreement (including, without limitation, all principal, accrued and unpaid interest, fees and expenses) have been repaid in full and the Secured Party wishes to release the security interest granted in the Security Agreement;


NOW THEREFORE, in consideration of the foregoing, the Secured Party does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Security Agreement, including, without limitation, the US Trademark Collateral. The Secured Party hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.

The Secured Party agrees, at Grantor’s expense, to cooperate with Grantor and to provide Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party’s security interest in the released collateral described herein.
