## TRADEMARK ASSIGNMENT

3. This Assignment and all the terms hereof shall inure to the benefit of Assignee, and be binding upon Assignor, and their respective successors, assigns and legal representatives.

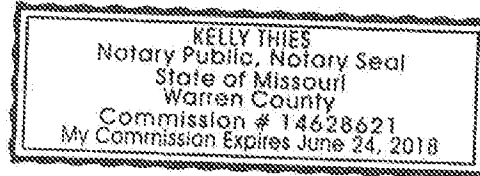
