## INTELLECTUAL PROPERTY ASSIGNMENT

27 THIS INTELLECTUAL PROPERTY ASSIGNMENT ("Assignment") effective as of this day of November 2017 (the "Effective Date"), is made by and between Alaskan Park Properties, Inc. ("Assignor") and CATC Alaska Tourism Corporation ("Assignee").

NOW, THEREFORE, for good and valuable consideration as agreed upon by the parties, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:

1. **Assignment.** Assignor hereby conveys, transfers and assigns irrevocably to Assignee, all rights, title and interests in and to the Trademarks, together with the registrations and any pending applications thereof and the goodwill of the business symbolized thereby in connection with the goods and/or services for which the Trademarks are used; together with all rights to sue for past, present or future infringements of any of the foregoing.
2. **Assurances.** Assignor agrees to execute and deliver to Assignee all such further assignments, transfers, authorizations, powers of attorney, assurances and other papers, and to perform any and all further acts as may be deemed reasonably necessary or desirable by Assignee for Assignee to obtain the full benefit of this Assignment, including, without limitation, documentation in connection with the recording of this Assignment in the United States Patent and Trademark Office and any other national or regional governmental intellectual property office.
3. **Jurisdiction.** This Assignment shall be construed and interpreted in accordance with and governed by the laws of the state of Arizona, without regard to the conflicts of law principles thereof.
4. **Counterparts.** This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same Assignment.
