## TRADEMARK ASSIGNMENT OF SECURITY INTEREST

January 3, 2018

WHEREAS, Brightstar Corp., a Delaware corporation located at 9725 NW 117 Avenue, #105, Miami, FL 33178 (“Brightstar”), Brightstar Device Protection, LLC, a Delaware limited liability corporation located at 2325 Lakeview Parkway, Suite 700, Alpharetta, GA 30009 (“BSDP”), have adopted, used and is using the marks shown in the attached Schedule A (the “Marks”), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Brightstar and BSDP are obligated to PNC Bank, National Association (“PNC”) and various other financial institutions (collectively, “Lenders”) and PNC as administrative agent for Lenders (“Agent”) pursuant to (i) a certain Sixth Amended and Restated Revolving Credit and Security Agreement, dated as of November 30, 2017, among Agent, Lenders, Brightstar, Brightstar US, Inc., Offwire, Inc. (each a “Borrower” and collectively, the “Borrowers”) and certain affiliates of the Borrowers (including, without limitation, BSDP) from time to time a party thereto (together with Borrowers, each a “Loan Party” and collectively, “Loan Parties”) and (ii) a certain Trademark Collateral Security Agreement, dated as of December 19, 2017, made by Loan Parties in favor of Agent (as each has been and may be further amended, modified, restated or supplemented from time to time, collectively, the “Agreements”); and


WHEREAS, pursuant to the Agreements, Brightstar and BSDP are granting to Agent for its benefit and for the ratable benefit of Lenders a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Brightstar and BSDP do hereby assign unto Agent for its benefit and for the ratable benefit of Lenders and grant to Agent for its benefit and for the ratable benefit of Lenders a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.


