**CONFIRMATION OF RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

2. Lender hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Borrower. Lender authorizes Borrower (or their agents) to file such documentation as is necessary to effect the releases of the security interests over the Trademarks as provided herein.
3. Delivery of an executed signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed signature page of this Release.
