TRADEMARK ASSIGNMENT

WHEREAS, Cheetah Mobile Inc., a company incorporated under the laws of Cayman islands, ("Assignor"), has agreed to sell and assign to Live.me Inc., a company incorporated under the laws of Cayman islands ("Assignee"), its successors, assigns, nominees, or other legal representatives, the entire right, title, interest and goodwill in and to all of its trademarks, either registered, pending or at common law, including, without limitation, the trademarks used for Live.me applications ("Target App") as identified on Exhibit A attached hereto (collectively, the "Trademarks").

WHEREAS, in order to effectuate Assignor's assignment to Assignee of its entire rights, title and interests in and to the Trademarks, Assignor is executing this instrument of assignment.

FOR GOOD AND VALUABLE CONSIDERATION, Assignor hereby assigns, transfers and conveys to Assignee, Assignor's entire worldwide right, title and interest in and to, including any and all common law rights thereto, as well as the goodwill of the business symbolized by, the Trademarks effective from November 1, 2016 ("Effective Date"). Assignee hereby grants a license for Assignor and its affiliates to reasonably use the Trademarks for the business of Assignor and its affiliates after the Effective Date.

Together with Assignor's worldwide right, title and interest in and to each of the Trademarks, as well as the goodwill of the business associated with said Trademarks being assigned to Assignee, are the rights to police, monitor and enforce said Trademarks against any and all past, current and future infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this present Trademark Assignment, together with any and all further privileges in the United States and throughout the world to establish use, ownership, and registration of the Trademarks.

Assignor hereby covenants and warrants that, with respect to each Trademark, it has the full right to convey its above-described right, title, interest and goodwill by this instrument, free of any encumbrances. Assignor further covenants and warrants that no other agreement has been or will be executed in conflict herewith.

Assignee agrees that assignee shall pay a consideration of USD [350,000] to Assignor for the assignment of Trademarks within 20 business days from the agreement effective date or a later date as agreed by Assignor. Assignor agrees to perform all affirmative acts which may be necessary or desirable to record or perfect the above-described transfer of trademark rights, or to secure registration before the United States Patent and Trademark Office or any foreign trademark office, at Assignee's expense, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the Trademarks, again at Assignee's expense.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, and the appropriate official in any other country, to issue any and all trademark registrations, amended registrations and renewals that may be granted upon any application or petition for same, to Assignee, and Assignee's successors and assigns. The parties agree to sign additional agreements, documents that may be required by the Commissioner of Patents and

Trademarks of the United States or any foreign trademark office in any other countries, upon mutual confirmation on the form and substance, to complete the procedure of assignment.

Assignor hereby grants to the designated attorneys of Assignee, the authority and power to insert on this instrument, any further identification which may be necessary or desirable for purposes of recordation by the United States Patent and Trademark Office or the Trademark Office of any other country throughout the world.

This Trademark Assignment constitutes the entire agreement and supersedes all prior agreements between the parties pertaining solely to the transfer of the Trademarks, and shall be deemed binding upon the parties, their heirs, legal representatives and successors.

This Trademark Assignment may be executed in one or more counterparts (including by means of facsimile), each of which when executed shall be deemed to be an original, but all of which together shall constitute one and the same instrument. This Trademark Assignment shall be governed by and construed in accordance with the laws of The People's Republic of China. .



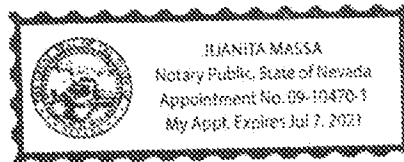

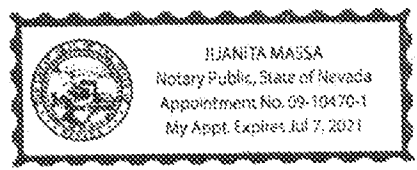
